- I understand that membership to the club is for a **calendar** year only regardless of first date of registration and is due for renewal in January 2024.
- Please Note: Every applicant/Parent/Guardian must be aware that the Academy section of the club that you/your child is enrolling into is a competitive boxing group. The training does contain full contact boxing. These classes are aimed at those who have the ambition to go on to compete for the club in tournaments if they reach the required standards. To reach these standards will take time and no one will be rushed into competing. We only allow those who attain this level, in their coaches' opinion, to compete.
